# <u>Trail Head Building Roof Replacement Estimate – Tabled from 10/16/2021 Meeting</u>

Review of estimates for roof repair, soffit and fascia on 401 Trail Head building from Tim Kruse Construction, Inc \$6,260.00 for roof. Grooms Exteriors \$6,250.00 for soffit and fascia. Honest Abe Roofing for shingle roofing \$20,790.00 and metal roofing \$23,890.00. The Town Council decided to table to give them a chance to get more information and review the estimates.

# Old Town Hall Siding Replacement Estimate - Tabled from 10/16/2021 Meeting

Grooms Exteriors for siding, soffit, fascia, gutters and downspouts \$33,230.00. Town Council decided siding is not feasible right now in the budget. The option of having the building painted instead was brought up. They would like estimates on having the building painted.

# Add Building Bathroom and Office in Town Garage to Town Project List - Brian Cook

Brian would like to have office in Town garage. The walls can be framed up and built during the winter months when he is not as busy. Stacy wants him to make sure to insulate the office so computer and other office equipment will not freeze in the winter. This was a project that should have been completed last 2 years but the past employees did not get around to ever completing it.

"To-Do List" Update

**Monthly Work Report** 

The One-Way signs for Terry Ln and W. 4<sup>th</sup> St. have been put up. The signs for E. 2<sup>nd</sup> St. have not been put up yet.

There are 276 meters in the ground and are hoping to finish the rest by next month. Due to the excessive rain, we have been mowing quite a bit so the meters have been put aside for the last week. Larger meters are required at the schools and Casey's which will require their water to be turned off for a longer period than the residential meters. It was discussed doing these meters at night, weekends or a time they are not opened. Brian said he would work something out with each of them to cause the least amount of disturbance.

Brian would like to have some inventory on hand so every time they need fittings or some sort of supplies, they don't have to waste 1-2 hours going to get supplies and hoping the stores have what they need in stock. The Town Council agreed this was a good idea but would need to keep the inventory documented.

The inside of a tree on fell and was blocking W. 3<sup>rd</sup> St. during one of the storms. The part blocking the street has been cut up and removed. The whole inside of the tree is rotted and resident has been informed and is planning to have it taken down before any damage is caused by it.

All last month water testing and hydrant flushing has been performed on various parts of the town.

There were questions about snow removal for the trail. Brian said it should not be done with the tractor. It was decided snow removal on the trail would not be a priority if they did not have the proper equipment.

There was discussion on advertising for extra help for Brian to do mowing and any other jobs preventing from doing the work he should be doing.

There are 5-6 long term campers staying until after December 2021. Weekends are booked into December.

A.J. Mason put up signs for unauthorized vehicles on Tecumseh Trails. The Peach St access is open so that can be tidied up.

There are beavers that have built a dam underneath the interstate which is causing the water to be about 2-3ft higher than normal.

They would like to establish a dog park area. The playground is being stripped and repainted.

The Park will be entering a float and the boat on a trailer with Santa into the Town's Christmas Parade.
