Stacy advises to tell the residents to call DNR whenever the hunter comes out to hunt again. The hunter was in a white f150 coal mine truck. Brian called coal mine their response was they didn't know who it was. Stacy advises again to call DNR and stress the reason for their call.

Stacy asked how it was coming along with getting the information to have reservation online with Reserve America. Bill said they were still getting all information filled out and turned in. Also checking into Municode.
