Property Complaint at 220 Cherry St – Donna Ghormley

Tree from neighbor's property fell on her house and did a significant amount of damage. Problem resolved between neighbors but wanted the complaint recorded until the problem is completely resolved. Reevaluate issue before October 5, 2021, meeting to decide if any further action should be taken.

Lynnville Lake Presentation - DNR

Kip Turpin- Indiana Department of Natural resources. The Abandoned Mine Land program is in place to take care of problems left behind from mining that occurred before the Surface Mining Reclamation and Control Act was started. Lynnville Park is an example of one of these mines. One of the features left behind is the dangerous high wall that is a liability cut. There is about 3,000 ft of dangerous highwall and a little over 30 acres, most being unusable at this time, that will be affected. As for the "Falls" there are a couple of options the engineers have put together but are open to new suggestions. One option is to make the area have a short drop of 4 feet and a run of 10 ft to make it stair stepped or cascading waterfall to still have a waterfall. Another option would be to chip the bed rock back so there wasn't a waterfall at all. It would be like a pool in your backyard. We can plant trees around. Slides of pictures were shown for different options.

At this time many people were talking over each other and were not given the floor. Identities could not be deciphered and many of the questions and comments could not be understood due to the excess noise of people talking at the same time.

Questions asked by residents given the floor.

Jackie Weil: How long would construction take? Kent: the construction period would run from January- October. Kent doesn't know how long boating access would be denied in this area during that time period.

Bruce Clark: Will the part of the lake be lost by the swim beach? Kent: That section will remain untouched.

Eric Lindenschmidt: the swim beach is very shallow. It is hard for kayakers.

Could not understand name: How many people live and pay to be on the lake go to the "Falls" to jump off and swim? Is it really a big problem? **Stacy**: They are trespassing by going through the cemetery and not the gate and they also post photos jumping off the falls on social media that is against the rules.

Tim Lillpop: Who makes the final decision/vote? Stacy: Town Council are tabling it and voting on it at the next meeting. Again, if anybody has any suggestions or alternative plans or suggestions, please feel free to send them to Town Hall.

Tm Lillpop: What is a price of this project and how many injuries/crimes are there really at Lynnville Lake? Kent: These are federal grants that will pay for this. The Town of Lynnville taxpayers will not be paying for this project. We cannot give an estimate because it needs to go to Indianapolis for it to be bid on. The highwall gives the town a liability issue which is why we get grants from the State and Federal Governments to take care of the issue.

Could not understand name: Where does the money come from if not from taxpayers? Kent: the mines are taxed a percentage on each ton of coal. That percentage is put into a fund for these types of projects.

Tom Barclay: What will happen if the landowner of the private property says no? Stacy: This project does not require to go on any private property. This is all on Lynnville Park property owned by the Town of Lynnville.

Dale McCuiston: I am grateful for people like you who do your job to keep everyone safe. Stacy: There is no way to keep people out from the cemetery access. This will be tabled until the next meeting but anyone who wants to state any comments or concerns, please do so at this time.
